An Anonymous Reporting System (ARS) is a technology-based prevention strategy that helps students identify the signs of a potential threat and know how to confidentially report their concerns to school leaders. Key Takeaways

- ✓ Students often have knowledge or awareness of situations that adults do not. Creating a way to report anonymously removes many of the perceived barriers (such as betraying one's friends) to sharing this sensitive information.
- ✓ Education on recognizing warning signs and the importance of reporting early is a vital component of the success of any ARS.
- ✓ An effective and responsible ARS model features redundancy and facilitates collaboration between the response team and external collaborators.
- ✓ An ARS needs 24/7/365 monitoring and vetting in order to be successful, as tips often come in based on social media observed during student free time outside of school.
- ✓ The technology that powers an ARS should be robust and security-focused with data tracking and the ability to share information quickly.
- ✓ To have long-term success, an ARS should have regular and ongoing engagement efforts and training on utilizing the system.
